ERRATUM

A correction has been made to the calculation of the skins component of the ANZ Commodity Price Index. This correction is the result of an error in the derivation of the skins series.

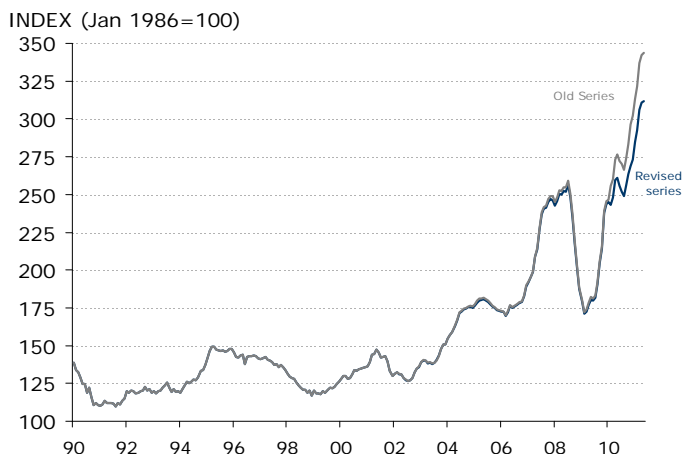
The earlier calculation was overstating the lift in pelt prices, particularly from January 2010 onwards. This has affected the world and New Zealand dollar values for the Meats, Pelts and Wools Index and hence the total world and New Zealand dollar values of the total ANZ Commodity Price Index. The corrected series are presented overleaf. All of the other series in the ANZ Commodity Price Index are unchanged.

The updated headline series shows the same broad trends including the strong lift in prices recorded since mid 2009. The level of the updated series is 9 percent below the prior one but nevertheless remains at a record high for the series.

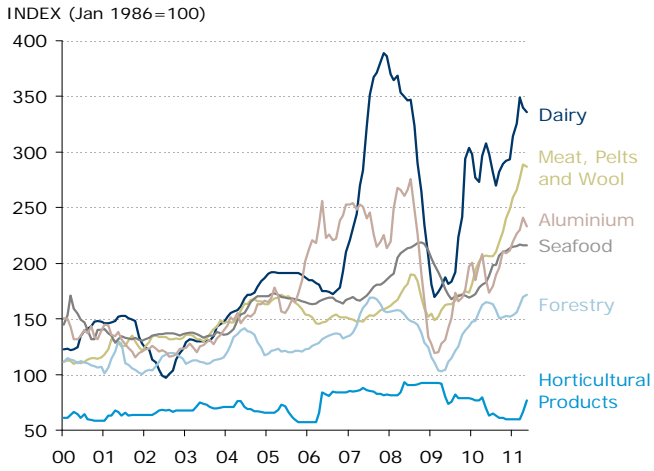

A number of other export commodities, such as oil, are becoming increasingly relevant determinants of export incomes, even though we may also import them as well.

ANZ COMMODITY PRICE INDEX

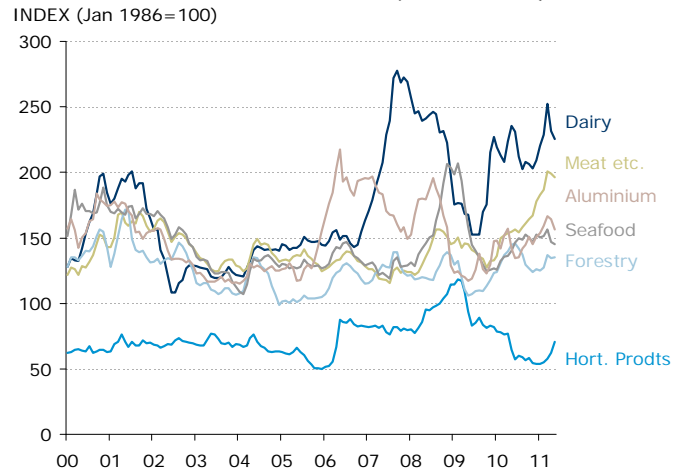


ANZ COMMODITY PRICE INDEX

Qualifications, experience and professional standing Experience

The Bank subscribes to relevant industry publications and, where appropriate, its investment advisers will monitor the financial markets.

Professional indemnity insurance

The Bank (and its subsidiaries), through its ultimate parent company Australia and New Zealand Banking Group Limited, has professional indemnity insurance which covers its activities including those of investment advisers it employs.

This insurance covers issues (including 'prior acts') arising from staff fraud, electronic crime, documentary fraud and physical loss of property. The scope of the insurance also extends to third party civil claims, including those for negligence. The level of cover is of an amount commensurate with the size and scale of the Bank.
